
It is a well known fact in Europa and in U.S.A. that exercises is one of the best treatments for a Parkinson patient.

He was very active – vigorous dancing, sailing, working on his 2 sailboats, helping me in my yard and working on his own house, I believe he still is roller skating. I think he had the essential tremor in one hand at the time. I believe it was 2008 when he went on a dancing cruise and came home with Legionella disease. He also was diagnosed with sleep apnea, and kidney stones. He became less able to be active and Parkinson's was

diagnosed. Problems with balance, jerking movements and more tremors began. Even walking was difficult, so he preferred to go to movies.

Enter Jennifer about 3 years ago who researched the Parkinson's and found medical and community help for it, convinced Larry to use the CPAP machine for sleep apnea, made CocaCola a lot less available around the house (It's bad for the kidney stones) and walking became a real part of the daily routine. A Parkinson group introduced some exercising and stationary biking that helped with limberness, balance and fluidity of movement.

Larry began to get stronger and all we ladies who danced with him through those "improving" months noticed the difference in his strength and balance as well as the smoother movements. The Parkinson experts stress keeping moving and we saw proof that it helps. Thank you Jennifer.

Now that we can't find him at his home, we friends miss him. We were planning a birthday party for him (10/31 – his 80<sup>th</sup> birthday). Social connections are important to Parkinson's people as they are to folks with other neurological problems. The connections are important to the friends, as well.

I know that Jennifer is employed by Larry. Her first work was cleaning his house. The house was in disarray, and the primary first cleaning implements were a shovel and a push broom. I have known her to clean houses on several other occasions that were in severe disarray and return them to a habitable condition. She is very good at it.

Her employment duties gradually transitioned, or expanded, from just this work, to odd jobs and maintenance tasks, to a sort of personal attendant and personal trainer. The primary item that led to her work being more of a personal attendant was a CPAP machine. After noticing that Larry was habitually groggy and falling asleep, she researched the issue and suspected the problem might be sleep apnea. She arranged for him to visit the appropriate specialists and it was confirmed, and a CPAP was prescribed. But it was problematic. Larry could not put his CPAP mask on securely enough for it to work properly, and would take it off in his sleep. She was instrumental in getting past this, and Larry began showing improvement in overall alertness. She became a live-in attendant, and was paid a modest daily stipend.

Jennifer was very happy to relate to me favorable comments from the neighbor's, who saw them out walking now. The neighbor's were very happy to see the improvements in Larry, and his home, and to see him getting the care that they knew he needed.

The sleep apnea was the first medical condition she attended to, but Larry had also been diagnosed with Parkinson's. Larry described it as being a 'death sentence'. Jennifer researched Parkinson's to learn what the current thinking was regarding treatment, and what the locally available resources were. After consulting with many professionals, and much reading, she gradually worked out a regimen of exercises and a routine of activities intended to enhance his alertness and mobility. But she did not force this on him. She

was doing the research and structuring, but he was able to select and refuse what was unacceptable. He clearly did find some of the exercises, especially riding the stationary bicycle, very onerous, but it seemed to me he accepted some of the unpleasant parts because he believed in the goal, and this means, of fighting back against Parkinson's and gaining some measure of freedom. He could certainly say no when he didn't want to do something, and did many times. So when he acceded to something he complained about, it seemed to me that even though he complained, it was still his choice to proceed.

While they were still employer and hired help, they were also friends, and the relationship did seem to me to become somewhat familial. They had squabbles where each felt the other had behaved badly or was being unreasonable, but after a short time the work would resume.

And it was quite successful. One of the professionals they saw regularly had counseled at one point that "you can't reverse Parkinson's", but later told Jennifer that she had done it.

It was obvious to me that there had been much improvement. Larry stood straighter, strode with more command and sureness, and seemed to be enjoying himself more.

Besides sailing on his beloved sailboat, he also went roller skating, and snow skiing. They took trips related to Scandinavian Folk dancing, an interest they had in common.

At no time did I see a hint of avarice, or cavalier treatment of Larry's belongings, or financial resources. Her reward seemed to be in the achievement of increased well-being for Larry, in having a stable living arrangement at low cost, and in being employed in a





Sometime around 4 years ago he started looking real bad. He was physically declining real fast and his memory wasn't so good. We were all really worried about his driving. He was still driving himself to the dances. We all thought he would kill himself or someone else.

I remember one time 3 or 4 years ago he passed out on the dance floor and he was living alone. He was a wreck. He could hardly stand up himself. I don't see how he could dance at all. He did pretty much stop dancing and just would sit and watch or have cake in the cafe and visit with friends.



He was conversant with us. Once time in August 2012, I walked up two flights of stairs behind Larry in the manner I have been trained to, spotting him, making sure he was safe. 




program at the Y. I wasn't able to enroll in that program because of work, but she encouraged me to get back on my bicycle as I used to ride often.


